NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, read with the Notification No. F5/4/65-GP, dated 11th January, 1965 of the Government of India, Ministry of Home Affairs, New Delhi, and in supersession of the notification issued vide G.O. Ms. No. 53/90/F5, dated 25th July, 1990 of the Finance Department, Pendicherry, and published as Supplement to the Official Gazette No. 32, dated 7th August, 1990, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Pendicherry, hereby makes the following rules, regulating the method of recruitment to the Group 'B' post of Data Processing Assistant in the Planning and Research Department, Pendicherry, namely:—

- 1. Short title and commencement.— (1) These rules may be called the Government of Pondicherry, Planning and Research Department, Group B post of Deta Processing Assistant Recruitment Rules, 2003.
 - (2) They shall come into force on and from the date of their publication in the official gazette.
- 2. Number of posts, its classification and scale of pay.— The number of the said post, its classification and the scale of pay attached thereto, shall be as specified in columns (2) to (4) of the schedule annexed hereto.
- 3. Method of recruitment, age limit and other qualifications. The method of recruitment to the said post, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (14) of the said schedule.

- 5. Power to relax.— Where the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.— Nothing in these rules shall affect the reservations, relaxations in upper age limit and other concessions required to be provided for the scheduled castes, the scheduled tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
