Sub: DIT – Estt - Grant of 2nd Financial Up-gradation to the 8 IT officials under MACPS - Orders - Issued.

On the recommendation of the Screening Committee and in terms of G.O.Ms.No.84, dated 26.08.2009 of Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry, the **8 Data Entry Operators** listed in the Annexure are hereby granted **2nd Financial up-gradation** under the Modified Assured Career Progression Scheme to the immediate next higher **level 7** in the Pay Matrix to the **Grade Pay of Rs. 4600/-** as given in Part A of Schedule of the CCS (Revised Pay) Rules, 2016, **with effect from the dates mentioned in column 6 in the Annexure.**

2. The Financial up-gradation granted herein are subject to the following conditions:-

- a. The financial up-gradation will not result in change in the designation of the beneficiary and shall not confer any privilege related to higher status.
- b. Benefit of pay fixation available at the time of regular promotion shall also be allowed, i.e., the pay shall be raised to next higher level in the Pay Matrix before such up-gradation.
- c. There shall, be no further fixation of pay at the time of regular promotion, if it is in the same Level as granted under MACP Scheme. However, at the time of actual promotion if it happens to be in a post carrying higher Level than what is available under MACP Scheme, no pay fixation would be available and only difference of Level would be made available.
- d. The fixation of pay in the level pay is also subject to review by Audit. Any over payment on account of pay fixation in the upgraded level will be recovered in lump sum.
- e. The employee is entitled to exercise option to get the pay fixed in the higher level pay, on the date of increment in the lower pay level under FR 22 (1) (a)(i) within a month from the date of receipt of this order.
- f. No past cases would be re-opened. Further, while implementing the MACP Scheme, the differences in pay scales on account of grant of financial up-gradation under the old ACP Scheme (of August 1999) and under the MACP Scheme within the same cadre shall not construed as an anomaly.
- g. The financial up-gradation given herein will further be governed by the terms and conditions stipulated and also clarifications issued from time to time under MACPS, notified by the Govt. of India communicated in G.O(1) cited.
