## **ORDER**

The Government of India has recently formulated CSC 2.0 Scheme in pursuance of the Government's commitment to set up one CSC at each of the 2.5 lakh Gram Panchayats to prove public services to citizens living in the rural areas. This would also include strengthening and integrating the one lakh CSCs already set up and operational under the existing CSC Scheme and operationalising additional 1.5 lakh CSC s at Gram Panchayat level. The Scheme provides manpower support to the State Designated Agency(SDA) to ensure implementation of a robust functional/transacting CSC outlet network in the State. The Puducherry e-Governance Society being the State Designated Agency(SDA) in the Union Territory of Puducherry has constituted a committee for the selection and appraisal of State level Resource i.e., Project Manager to ensure implementation of robust functional/transacting CSC outlet network in the State as per the following composition.

- 2. Further the Govt. of India has requested for integration of all Departmental portals at State/UT level with Apna CSC portal so that all the e-services can be delivered through Common Services Centres, which in turn would result in ease of accessibility of services by the citizens and thereby making the Common Services Centres sustainable.
- All portals designed, developed and hosted by various Departments of Government of Puducherry have to be integrated with Apna CSC portal. The above Constituted Committee cited vide para.1 in addition to the selection of Project Resources, will identify various services being delivered through different portals and integrate it with Apna-CSC through the co-ordination between various Departments and Public Authorities. In addition to the above members, the Chairman may co-opt with the respective Head of Department as member whose portal is proposed to be integrated. The Committee would be in existence permanently and shall meet at least once in three months or as and when necessity arises
