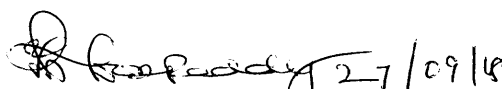

As per the direction of Chief Secretary, this Directorate is in the process of implementing File Tracking System / Manav Sampada (e-HRMS) / GeM / Migration of websites / Revamping of websites in the U.T. of Puducherry. Necessary training has been imparted on these projects to the Officials nominated by respective Departments. As a follow up measure, an Orientation Programme was held on 07-09-2018 to the IT officials working in various Departments for migration to cloud and to sensitize them on File Tracking System / Manav Sampada (eHRMS) / GeM, etc. Further, the websites of all Govt. Departments / Institutions have to be converted into Persons with Disability friendly and in compliance with GIGW & WCAG 2.0. Already websites of 18 Departments have been revamped. Now another set of 24 websites are taken up for revamping in association with ERNET. Necessary circular has been sent to the concerned Departments / Offices.

In partial modification of the circular cited under reference-1, the IT personnel working in various Departments as indicated in the annexure shall co-ordinate and provide necessary technical assistance to the Private Secretaries / Personal Assistants / Dealing Assistants/ Nodal Officers working in various Departments for implementing the following IT Projects.

- 1) File Tracking System
- 2) Manav Sampada(e-HRMS)
- 3) Procurement of goods & services through GeM
- 4) Migration of websites/applications to NIC cloud
- 5) Revamping of websites.

Further, they should submit progress/status report every Friday without fail till all the above tasks are completely implemented.
